Client Suitability

- The PNB Prestige Peso Money Market Fund is suitable for investors who have conservative risk appetite.
- The Fund's investment horizon shall be one year or less.

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

Fund's Investment Objective

The PNB Prestige Peso Money Market Fund is a Unit Investment Trust Fund structured as a multi-class fund that is invested in a diversified portfolio of bank deposits and fixed income instruments issued by the Philippine government with a remaining term to maturity of not more than three (3) years and has a weighted average portfolio life of one (1) year or less.

It allows investors to invest a much smaller amount and invest in high yielding deposits and fixed income instruments that were only previously available to investors with sizeable funds. Additionally, they also get a diversified portfolio, which helps reduce risk and enjoy the benefits of having their funds managed by a professional investment manager.

The Fund is suited for conservative clients who want an investment strategy where the primary objective is to prevent the loss of principal and where the fund is invested in securities issued by the National Government and/or deposits with local banks/branches of foreign banks operating in the Philippines and/or with financial institutions in any foreign country: Provided, That said financial institution has at least an investment grade credit rating from a reputable international credit rating agency.

Fund's Investment Policy

The Fund may be invested in any of the following allowable investment instruments:

- Evidences of indebtedness issued by or guaranteed by the government of the Republic of the Philippines or the Bangko Sentral ng Pilipinas.
- Deposits with local banks/branches of foreign banks operating in the Philippines and/or with financial institutions in any foreign country: Provided, that said financial institution has at least an investment grade credit rating from a reputable international credit rating agency. and treasury units of the Trustee.
- Such other tradable financial instruments as may be allowed by the BSP.

The Fund's investment horizon shall be one year or less.

Risk Considerations

Liquidity Risk	The possibility for a Trustor to experience losses due to the Fund's inability to sell or convert assets into cash immediately or in instances where conversion to cash is possible but at a loss.
Credit Risk	The possibility for a Trustor to experience losses in the event the borrower/issuer defaults on his obligation or in the case of a counterparty, when it fails to deliver on the agreed trade.
Reinvestment Risk	This is the risk associated with the possibility that the funds may not be invested at the same rate as it was invested previously.
Interest Rate/Price Risk	This is the possibility for a Trustor to experience losses due to changes in interest rates or due to a decline in the price of a security or a portfolio.

Cooling Off Provision

The participant of the Fund may avail of the cooling-off period of two (2) business days immediately following the approval of the participation to cancel his participation without penalty, subject to submission of a written notice during the cooling off period.
